

A RESOLUTION BY COUNCILMEMBER JOYCE M. SHEPERD AUTHORIZING THE MAYOR, ON BEHALF OF THE CITY, TO ACCEPT A DONATION VALUED AT THIRTY-FOUR THOUSAND DOLLARS AND ZERO CENTS (\$34,000.00) FROM THE ANNE E. CASEY FOUNDATION FOR THE SHIPPING, INSTALLATION, AND MAINTENANCE OF FOUR SCULPTURES TO BE LOCATED IN PITTMAN PARK; AND FOR OTHER PURPOSES.

WHEREAS, the Annie E. Casey Foundation (“AECF”) is a 501(c)(3) non-profit organization that is devoted to developing a brighter future for millions of children by focusing on strengthening families, building stronger communities and ensuring access to opportunity; and

WHEREAS, AECF is transforming a 31-acre industrial site at 352 University Avenue into Pittsburgh Yards, a vibrant space where residents can work, shop, create, and play; and

WHEREAS, redevelopment of this site has required the need to relocate four, geometric sculptures currently located at the site (attached hereto as Exhibit “A”); and

WHEREAS, AECF has proposed to donate the four sculptures to the Mayor’s Office of Cultural Affairs, where they will be installed in Pittman Park; and

WHEREAS, as a part of this donation includes Five Thousand Dollars and Zero Cents (\$5,000.00) to restore and install each sculpture, and One Thousand Dollars and Zero Cents (\$1,000.00) that will be used for future maintenance of the sculptures; and

WHEREAS, the City of Atlanta is appreciative of the generosity of the Annie E. Casey Foundation.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, that the Mayor, on behalf of the City, is authorized to accept a donation from the Annie E. Casey Foundation for the restoration, installation, and maintenance of four geometric sculptures (attached hereto as Exhibit “A”), valued at Thirty-Four Thousand Dollars and Zero Cents (\$34,000.00).

BE IT FURTHER RESOLVED, that to the extent that the Annie E. Casey Foundation is donating resources to the City, the City hereby accepts the donation.

BE IT FINALLY RESOLVED, that all resolutions and parts of resolutions in conflict herewith are hereby repealed for the purposes of this resolution only, and only to the extent of the conflict.
